Hydraulic fracturing, or "fracking," is the process of injecting fluid into a previously drilled wellbore at a high pressure in order to fracture subterranean formations to release hydrocarbons. Hyperbole surrounding fracking is widespread with claims of national energy independence mixed with videos of flammable tap water and assertions of environmental destruction. This symposium sets out to present both sides of the coin, while also analyzing related legal and policy issues.



JACQUELINE L. WEAVER

Jacqueline L. Weaver is the A.A. White Professor of Law at the University of Houston Law Center. Her teaching and research interests cover oil and gas law, energy law and policy, international petroleum, and environmental and natural resources law. She is a co-author of the nationally used casebook titled Energy, Economics and the Environment, and the treatise International Petroleum Exploration & Exploitation Agreements (Barrows Publishing 2009). ROBERT HOWARTH

Professor Howarth is the David R. Atkinson Professor of Ecology & Environmental Biology at Cornell University. Trained as an Earth systems scientist, Dr. Howarth has worked on global change and pollution from the oil and gas industry for 35 years. He has published over 200 books and papers, including several on the greenhouse gas footprint of shale gas. He has testified before the US Congress and the EU Parliament on shale gas, and was named one of "50 People who Matter" in 2011 for his shale gas research. In 2011, Dr. Holditch was appointed to a subcommittee of the United States Secretary of Energy's Advisory Board to make recommendations to improve the safety and environmental performance of natural gas hydraulic fracturing.
